FAQ For Call For Concept Notes on Investing in The Rain-Fed Agriculture in Sudan

Deadline: September 30, 2021

Question	Answer
In what language should the concept note be written?	English.
Is there a template for the concept note and the budget?	No. You can submit the concept note and budget in whatever format is convenient for you.
Is there a limitation on page numbers for the concept note?	Yes, maximum 10 pages excluding annexes.
Do you accept annexes to the concept note, for example to provide further details such as an organizational chart, previous experience and/ or management plan?	Yes, you can add annexes.
Are UN agencies eligible to submit a concept note?	NO. The multi-lateral organizations are not eligible to apply. Please note the criteria for eligibility that are mentioned (Applicants must implement the project themselves NOT ONLY act as an intermediary channel to provide financing to other implementing parties).
Are INGOs eligible to submit a concept note? Are local organizations eligible to submit a concept note?	Yes. Please note the criteria for selection that are mentioned (on having sufficient expertise and experience in the area).
Organization – what kinds of legal status permitted and what are registration requirements?	The applicant or the lead applicant must be legally registered in its country of origin, preferably with or able to have an appropriate registration to work in Sudan. When assessing proposals, we will also look at the capacity of the organization to implement the program. Note that (lead) organizations with successful concept notes will need to pass an organizational and financial assessment.
Is it possible to submit a concept note with a consortium? Are you looking for international or local organizations to submit a concept note?	We have no preference. What matters to us is that the organization(s) can give us confidence that they have the required capacity to implement the proposed programme, and to do so in a conflict-sensitive manner.
Can an organization be part of more than one consortium?	Yes, organizations can be part of more than one consortium. Note however that organization can only be lead organization (or sole submitting organization) for one concept note
How do we capture the budget given that you haven't provided the template for the same, or are we supposed to only provide summary budget?	At this point, a summary budget is sufficient. It should however include an explanation of how you come to the different amounts.
What are the (financial) conditions of the call? Is it a tender procedure, or a grant subsidy?	This will be a grant contribution.

Is co-funding required?	Yes, if the applicant or the lead applicant is based outside of the EU.
